Precautionary Statements – Prevention:

Section 4. First Aid Measures

Eye contact: Immediately flush eyes with plenty of water for at least 15 minutes. Get medical attention if irritation develops or persists.

Skin contact: Wash skin thoroughly with soap and water. Get medical attention if irritation develops and persists.

Inhalation: Remove victim to fresh air. If breathing is difficult, give oxygen. Get medical attention.

Ingestion: Immediately rinse mouth and drink plenty of water. Keep person under observation. Do not induce vomiting. If vomiting occurs, keep head low. If person becomes uncomfortable seek medical advice.

Section 5. Firefighting Measures

5.1. Extinguishing media

Suitable extinguishing media: Alcohol-resistant foam, carbon dioxide (CO₂), and dry chemical powder. Water spray may be used for cooling containers and dispersing vapors, but not for extinguishing the main fire. Unsuitable extinguishing media: Do not use a direct water jet, as it may spread the fire.

5.2. Special hazards arising from the substance or mixture

Cool endangered packaging with water spray jet.

Hazardous combustion products: May intensify fire; oxidizer.

5.3. Advice for firefighters

As in any fire, wear self-contained breathing apparatus and suitable protective clothing including gloves and eye/face protection.

Section 6. Accidental Release Measures

6.1 Personal precautions, protective equipment and emergency procedures

Ensure adequate ventilation. Keep people away from and upwind of spill/leak. Avoid inhalation, ingestion and contact with skin and eyes. When workers are facing concentrations above the exposure limit they must use appropriate certified respirators. Ensure clean-up is conducted by trained personnel only. Refer to protective measures listed in sections 7 and 8.

6.2 Environmental precautions

Do not allow to enter drainage system, surface or ground water. Do not allow to enter the ground/soil. Dilute with plenty of water. Inform responsible authorities in case undiluted product reaches drainage system, surface or ground water or the ground/soil.

6.3 Methods and material for containment and cleaning up

Absorb onto dry sand or similar inert material. Do not use fabric, sawdust, paper or other inflammable materials (danger of spontaneous combustion). Ensure adequate ventilation. Keep in suitable, closed containers for disposal.

Section 7. Handling and storage

7.1 Precautions for safe handling

Measures to prevent fire and explosions:

Keep away from heat, hot surfaces, sparks, open flames and other ignition sources. No smoking. Take precautionary measures against static discharges. Use explosion-proof electrical, ventilating or lighting equipment. Use non-sparking tools. Wear suitable protective clothing, gloves and eye/face protection.

Measures required to protect the environment:

For environmental exposure controls see subsection 8.

Advices on general occupational hygiene:

Handle in accordance with good industrial hygiene and safety practice. Keep away from food, drink and animal feeding stuffs. Do not mix with other products unless advised by Diversey. Wash hands before breaks and at the end of workday. Take off immediately all contaminated clothing. Avoid contact with skin. Do not breathe spray. Use only with adequate ventilation. 7.2 Conditions for safe storage, including any incompatibilities

Keep only in original packaging with a vented cap. Store in a closed container. Store in a well-ventilated place. Keep cool. Keep away from heat and direct sunlight. Keep at temperature between 15-25 °C. For conditions to avoid see subsection 10.4. For incompatible materials see subsection 10.5.

Personal protective equipment
